Project Youth Goals:

1. Raise academic achievement for youth
2. Improve social/emotional well-being for students and families
3. Increase parent and community engagement with school, afterschool and the student learning process

Program Schedules:

Project Youth Afterschool Programs are open Monday through Friday. Programs are not open on holidays, early release days and vacations. If a morning program is scheduled, it will remain open on early release days but will be closed if the school calls for a delayed entry. Please Note: Weather may cause unscheduled closings.

School Rules:

The Afterschool Program abides by the rules set in place by each school.

Personal Belongings:

Students' use of cell phones and other similar electronic communication devices is prohibited during the Afterschool Program. Students are encouraged to leave phones, iPods, and such electronic devices in their backpacks during this time.

Volunteer Recruitment:

The Afterschool Programs welcomes volunteers to serve as positive role models for youth and set good examples for their actions and behavior. We encourage parents, community members at large, college students and high school students to participate in the Afterschool Programs and share their talents with the students.

Program Closure Procedure:

If the Afterschool Program closes for any reason, you will be contacted by Call Multiplier which is an automated call system.

- **Note:** If you have questions or your child's program cancellation plans have changed, please call your Afterschool Program Site Director, NOT THE SCHOOL.
- **Note:** If we do not have your current phone number you will not be notified of program closures.

Attendance Schedules & Wait Lists:

If the expected attendance days for your child changes, you must notify the Site Director immediately. If your child fails to attend on the agreed upon days, your slot may be given to another child who is on a wait list.

Homework Help:

All students attending the Afterschool Program are enrolled in homework help and have the opportunity to complete their assignments. Sessions are staffed by Project Youth staff and certified teachers. We are not responsible for turning in students' homework. **(Please do not assume that all work is accurate and complete because your child attends the Afterschool Program. Parental involvement is vital and strongly recommended for academic and social success!)**

Academic Enrichment Activities:

The enrichment activities that are offered daily are age-appropriate and hands on. They are designed to improve self-esteem and social skills, create future-oriented goals, practice critical thinking and emphasize healthy choices. All enrichment activities link with the NH Common Core Standards.

Transportation:

Transportation rules are the same as the rules that apply when you ride the school bus to and from school and on field trips. The Afterschool Program bus stops will be the same as the morning school bus stops. Any questions on bussing can be addressed to the program Site Directors (phone numbers are on the back cover).

Please note that any disciplinary action received during the school day will be the same in the Afterschool Program. If a student has been suspended from riding the morning bus they will not be allowed on the Afterschool bus. ALSO, if a student is suspended from riding the Afterschool bus they will not be allowed on the morning bus.

Bus Rules:

- Remain seated forward for the entire ride.
- When windows are opened, hands and arms are to remain inside of the bus.
- Do not throw objects on the bus or out of the windows.
- Obey the bus driver's directions.
- Leave the bus clean of any papers or trash.
- Do not eat or drink on the bus.
- Keep your voices down as you talk.
- Be sure to keep the aisles clean of your belongings.
- Exit the bus at your correct bus stop.

Bus incident reports are handled as follows:

1st offense – written warning

2nd offense – 5 day suspension

3rd offense – 20 day suspension

4th offense – suspended for the remainder of the year

*Please understand that this is for school **and** Afterschool Program routes.*

Communication:

It is important that parents, students, and site directors communicate with one another to ensure a safe and positive environment. This includes having up-to-date contact information. If you have any comments, questions, or concerns please contact the Site Director at the appropriate site.

Updating Information:

Parents are responsible for notifying Project Youth of any change to their child's record including phone numbers, address, emergency and authorized pick-ups, billing, and changes to other pertinent information.

Correct phone numbers are critical! Without a working number you will not receive program closure notices.

Student Supervision & Discipline:

Students must be in the sight of program staff at all times unless given permission by a staff member to leave supervision. Students may not go into hallways, classrooms, offices, or outside unless accompanied by a staff member.

Project Youth uses positive discipline techniques and views discipline as an opportunity to guide behavior. We will **not tolerate** the following:

- Foul Language
- Bullying and/or harassment of any students or staff
- Physical or verbal abuse
- Smoking or use of any illegal substance
- Inappropriate use of the computers and/or internet
- Vandalism
- Stealing
- All safety issues will be addressed immediately! Students may be sent home if deemed necessary.

We do recognize that students may have had a bad day and may act out in negative ways. When this happens, behaviors will be addressed by staff as follows:

- Speak quietly and directly to the student(s).
- Invite the student to leave the room for private discussions if other students are around.
- Ask the student to express their feelings: staff will listen to the student, then evaluate the situation.
- If the student continues with negative behavior, notify the parent via phone.
- If necessary, follow-up with a written incident report.
- If negative behaviors continue, call parent and set up a meeting (include the student). The student cannot return to the program until this meeting occurs and a behavior plan is in place.

Students who demonstrate violence, and/or threaten other students or staff, may be dismissed immediately and permanently from the program.
